### Clarification on Verification of Local Content and Class I Local Supplier Status

As per the provisions of the Public Procurement (Preference to Make in India) Order, 2017, issued by the Department for Promotion of Industry and Internal Trade (DPIIT), Government of India, public sector entities are mandated to promote procurement from local suppliers to enhance domestic value addition and support indigenous capabilities.

In the context of this tender for Empanelment of Architectural Consultancy Services, the requirement for verification of local content and Class I Local Supplier status is necessary.

All bidders intending to claim Class I Local Supplier status must submit the required declaration along with their bid documents. The Bank will verify these claims in accordance with the latest guidelines under the Public Procurement Order and any amendments thereto.

### Clarification on Performance Report (Annexure E)

Annexure E should include performance reports from previous clients for similar architectural consultancy assignments. These reports must be signed and preferably on the letterhead of the issuing organization.

### Submission of Integrity Pact

The Integrity Pact must be submitted along with the tender documents. It should be duly signed by the authorized signatory of the bidder and stamped in Rs. 100.00 Non-Judicial Stamp Paper. Non-submission may lead to disqualification.





### Stamping of Oath Declaration

The oath declaration should be signed by the authorized signatory. Stamping is not mandatory unless notarization is required by the bidder's internal policy or local regulations.

All other terms and conditions of the tender remain unchanged.
